REPRESENTATIVE CASES

New York:

- Successfully defended a New York Labor Law case in which a worker was struck in the leg by a falling fan cowl cover, both at the summary judgment stage and on appeal.
- Successfully defended a New York Labor Law case involving a worker who fell into a floor hole during the renovation of a prominent Midtown theatre, both at the summary judgment stage and during the subsequent appeal.
- Successfully defended a New York Labor Law case involving a construction contractor at a Lowe's site, following a severe injury sustained by an ironworker, who became trapped by construction materials while his pant leg was caught in rebar.
- Successfully defended a New York Labor Law case involving a homeowner, where a painter sustained injuries after striking his head on a low door during painting work, necessitating multiple spinal surgeries.

- Successfully defended a New York Labor Law case against a general contractor, following an incident where the plaintiff was electrocuted while handling cables and fell from a ladder, resulting in severe injuries.

- Obtained a defense verdict at trial for a driver and the corporate vehicle owner accused of causing significant injuries to the plaintiff. Additionally, successfully had the claim for punitive damages dismissed on procedural grounds.
- Successfully defended a case against a trucking company involving a motorcycle accident resulting in the plaintiff's death.
- Successfully defended a homeowner against a suit after the plaintiff was discovered at the bottom of the homeowner's pool, leaving the plaintiff quadriplegic.
