For the first 226 days of her life, our daughter Charlotte slept in a hospital bed in a Cardiac Intensive Care Unit. On September 18, 2017, Charlotte was born two months early, at 3.1 pounds, with the most dangerous heart condition that exists: Hypoplastic Left Heart Syndrome (HLHS). Essentially, Charlotte was born with half of a functioning heart. At three-days-old Charlotte had open-chest surgery which was necessary for her survival. Charlotte has since had two major open-heart surgeries and within the next year, Charlotte will require a third major open-heart surgery. For now, Charlotte is home and doing well.
